## Florida's Gulfarium Camps Full and General Release 2010

Thank you for your participation in the Florida's Gulfarium Camps (the "Camp"). As a condition of your child's participation, please read and sign this Full and General Release. I am the parent or legal guardian of \_\_\_\_\_, a minor child, and I sign this Full and General Release on both my own and my child's behalf.

I acknowledge receipt of written materials and instructions relating to the Camp and assert that I have had an opportunity, prior to enrolling my child in the Camp to review these materials. As a condition of my child's participation in the Camp, I agree that my child will abide by such instructions. I acknowledge and agree that if my child fails to follow the instructions, he or she will be removed from the Camp.

I acknowledge and agree that my child's participation in the Camp may subject him or her to risk of personal injury, including death, and/or damage to property. I represent that I have voluntarily enrolled my child for participation in the Camp and assume all risks in relation to the Camp. I hereby covenant and agree that Gulf Exhibition Corporation ("GEC"), its parent, subsidiaries and affiliated entities and their respective officers, directors, employees and agents (the "Released Parties") shall not be liable for any damages (including without limitation, compensatory, punitive and exemplary damages, pain and suffering and damage to property) which may in any way result from or arise out of my child's participation in the Camp. On my own behalf, on behalf of my child, and on behalf of my child's heirs, executors, administrators, I hereby fully and forever RELEASE AND DISCHARGE AND COVENANT NOT TO SUE any of the Released Parties from any and all claims, demands, damages, rights of action or cause of action, present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my child's participation in the Camp.

I understand that this Full and General Release includes any claims based on the negligence, actions, or inactions of any of the above Released Parties and covers bodily injury, including death, and property damage, whether suffered by me, my child, before during or after such participation. I further authorize medical treatment for said child if the need arises. Regarding major medical emergencies or medical traumas, I further authorize representatives or agents or Released Parties to provide or consent to any emergency medical care that may become necessary. On my own behalf, on behalf of my child and on behalf of my child's heirs, executors, personal representatives, assigns, heirs and next of kin, I hereby RELEASE, DISCHARGE AND COVENANT NOT TO SUE the Released Parties for and further agree to indemnify and hold harmless the Released Parties from any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, arising from the provision or authorization of medical treatment.

I further acknowledge that I have had the opportunity to review this Full and General Release with an attorney of my choice, if I so choose, and I understand all of its terms and conditions.

I acknowledge and agree that if any provision or part of this Full and General Release shall be determined to be void by any court of competent jurisdiction, then such determination shall not affect any other provision or part of this Full and General Release and if any provision or part of this Full and General Release is capable of two constructions one of which would render the provision or part void and the other of which would render the provisions or part valid, then the provision or part shall have the meaning which renders it valid.

The parent or legal guardian acknowledges that he/she is over 18 years of age, is competent to sign this Full and General Release on his or her own and his or her child's behalf and has carefully read the above Full and General Release, knows the contents of the Release and signs this Release as his or her own free act.

## CODE OF CONDUCT

The Gulfarium takes a "Zero Tolerance" position against weapons or illegal drugs or any violent or abusive behavior in any summer camp environment, which includes all camp facilities or any onsite or offsite camp activities. Any person violating this policy will be subject to immediate expulsion from camp and appropriate legal action. For the safety of our animals and all Gulfarium visitors, we have adopted the following code:

- 1. When around animals participants must do exactly as instructed by Gulfarium staff.**
- 2. Shouting, vulgar, language, running, climbing, and tapping on exhibit glass are not permitted.**
- 3. Employee only areas are off-limits to all visitors unless escorted by Gulfarium staff.**
- 4. Certain activities may require that participants remain at all times within specified areas. At all times participants must remain with their assigned group.**
- 5. Participants are required to wear shoes at all times unless otherwise directed by Gulfarium staff.**
- 6. Trash is to be placed in trashcans only (not on the ground or floors).**

Failure to comply with this code of conduct may result in the loss of privileges, loss of hands on experience with animals, or expulsion from the program without refund.
